Laura Pressler, RN, Injury Prevention Outreach Coordinator from United Regional discussed many injury prevention opportunities including Child Passenger Safety, Car Fit for seniors, Teen Safe Driving and the opportunity to begin a new program in the spring regarding submersions and drownings in the spring throughout the area. We also reviewed a checklist sent from the TETAF meetings discussing guidelines for care of children in the emergency department.

Mary Thompson from Wilbarger General brought to light a challenge that several of our area hospitals are facing regarding neonatal and maternal transport after delivering in facilities with no maternal/infant care. There were also several questions of the training and certifications the staff at those facilities should have. After a lengthy discussion we determined that our transferring facilities face several education and equipment challenges with these types of situations. Contact will be made with the neonatal group and meetings will be set up to discuss this in December.
