 - Executive Director's report
 - She is sending out receipts for RAC dues paid. It is not an invoice.
 - The RAC is in need of a 6'X12' trailer with ramps for the new golf cart for the distracted driving program.
 - The Al Garcia Scholarship was awarded by Vernon College.
- The Governor's EMS and Trauma Advisory Council (GETAC) report was given by Ryan Matthews as follows:
 - GETAC EMS Committee Meeting will be held in Dallas on November 1 at 10 am. He urged all to attend for updates related to new EMS legislation and rules.
 - Texas has a new EMS Director, Joe Schmider. He has an EMS background from up north.
 - Medical directors need to have a contract with the service they are affiliated with.
- TETAF report was given by Bill Sokora:
 - Plans are underway to offer a Medical Directors course.
 - The 'Just Drive' program related to distracted driving is rolling out in select communities with plans for statewide availability in November.

■ The EMS Lunch and Learn series is scheduled to have more talks focused on administrative issues. Dr. Racht has put together some great speakers to present this series. As always it is free unless you desire the CE credit.

Old Business:

• The Advanced Skills workshop was a great success. Attendance included 50 participants. The success of the workshop has prompted consideration for holding it again next year.

New Business:

- Foster presented the need to have a dedicated person or firm to handle the filing requirements for the non-profit status of the Provider's Association. Suggestions included using the firm handling the RAC is using in Wichita Falls. No further action taken.
- Palo Pinto County has entities considering changing RAC affiliations from the Dallas RAC to North Texas RAC. Many questions related to the distribution of state funds and funding formulas would have to be answered.
