**c. DSHS:** Jerry Bradshaw stated that DSHS has moved licensing to a different department so there will be delay notices going out to EMS providers. Certification was also moved to a different office and has been brought current. Due to the shortfall of state money the RAC audits have been cancelled.

**d. Executive Director:** Melissa Whitelaw reserved comments for the new and old business portion of the agenda.

#### 5. Committee Reports:

- a. Trauma Coordinators: cancelled.
- **b. PHEMS:** Foster Simmons has nothing to report until after the PHEMS meeting is held. He will give a report at the general membership meeting.
- **c. PIE:** Laura Pressler reported 1 child drowning so far this summer. She presented two new pamphlets, one for drowning and one for stress management. Bowie had a CISM incident. Melissa and Laura will work on putting a call procedure on the NTRAC website. The car seat program will need to find other funding than Kohls. Please let Laura know if you have any suggestions or possible contacts.
- d. CQI: Kim Stringfellow spoke about SNAP software for CQI reporting. It is HIPPA compliant and will allow for blinded data to be collected. Estimated cost is \$145/month to link to the cloud. Software training will be tentatively scheduled for the 3<sup>rd</sup> week of June. Motion for approval. Laura Pressler made a motion to approve with a second from Roger Ritchie. Motion passed.
- **e. Pediatrics:** Lou Schaffer shared that Cooke's will be coming to United Regional on June 12<sup>th</sup> to teach a class on endocrinology ports in pediatrics. It will be a 1hour lecture with an additional 1 hour of hands on training.
- **f. Air Medical:** Roger Ritchie reported that Air-Evac has a new pad under contruction.
- **g. Acute Care:** Cindy Hoff reported that EKGs are looking good prior to round one STEMI. United Regional is partnering with UT Southwestern

on a tele-medicine pilot program for stroke patients that aren't TPA eligible. The hope is that this will lead to a strong stoke network.

**h. EMTF:** Not present.

- **a. LPG Ideas:** There will not be a LPG this year due to DSHS budget issues.
- **b. DSHS Stroke Program:** Joy Henry is still collecting data from EMS and hospitals.

- **c. DSHS Funding Issues:** Funding for this year is intact. DSHS is still working to secure the budget for FY2015. If they are unable to find any more money the tobacco budget will be cut by as much as 50%.
